Hello:

We are writing to inform you that your application for parental insurance benefits has been provisionally approved.

You are required, however, to provide us with your child's date of birth as soon as it is known. If this information is missing from your file, we may suspend the payment of your benefits.

We have enclosed a benefit calculation report, which takes into account the information we obtained to process your application. It is important to inform the Ministère promptly of any changes to the information provided, including the date you return to work. If you work or receive income while you are receiving benefits, you must declare the amounts.

In your application, you provided an estimate of your gross weekly employment income for the last 26 weeks. This estimate has also been taken into account. However, to determine the exact benefit amount to which you are entitled, we need to know your actual average weekly employment income. You must therefore provide us with your record(s) of employment for the 52 weeks preceding the benefit period within 4 weeks. If you do not comply, we may suspend your benefits and claim the benefits you have already received. When we obtain your record(s) of employment, we will reassess your file and modify the benefit amount as necessary. You will then receive a new decision notice and benefit calculation report containing the relevant benefit payment information.

If you selected direct deposit, your benefits will be safely deposited directly into your bank account. This will help you avoid the inconvenience of having to deposit a cheque and the delays associated with statutory holidays. If you receive your benefits by cheque, they will be delivered within the usual Canada Post delivery times. Note that you can change the payment method at any time by accessing your online file or by contacting the Centre de service à la clientèle.

You are entitled to request that our decision be reviewed, but you must submit your request within 90 days of receiving this notice. You can obtain a review request form by calling the number below or visiting the Québec Parental Insurance Plan website at rqap.gouv.qc.ca.
